- f) Has paid entrance fee **Kshs. 1,500/** and purchased a minimum of 500 shares capital @ **Kshs. 20** per share payable in installments of **Kshs. 2000/** for 5 months or one off payment as prescribed in the membership policy.
- g) Has completed member's nominee card, appointing a nominee(s).
- h) Has completed member's burial benevolent fund form, appointing dependent(s).
- i) Has understood the objectives of the Society, his obligations as a member and other membership requirements as stated in the Society By-law.
